

RESOLUTION 21-1871

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS AUTHORIZING THE CITY MANAGER TO EXECUTE TAX RESALE DEEDS FOR PROPERTIES SOLD BY TRAVIS COUNTY FOR WHICH THE CITY OF LAGO VISTA HAS AN INTEREST IN THE TAX FORECLOSURE JUDGMENT.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, THAT:**

WHEREAS, Texas Tax Code Section 34.05 authorizes the sale of property by a taxing unit that is a party to a judgment; and

WHEREAS, twelve (12) properties identified in Exhibit A attached hereto and incorporated herein are subject to a tax foreclosure judgment in Travis County; and

WHEREAS, the City of Lago Vista, is one of the taxing units with an interest in the tax foreclosure judgment against said properties; and

WHEREAS, Travis County, by and through the Travis County Commissioner's Court approved tax resale deeds for the twelve (12) properties identified in Exhibit A at their December 1, 2020 meeting; and

WHEREAS, by correspondence dated December 18, 2020, Travis County provided Tax Resale Deeds for Lago Vista property that has been sold pursuant to Texas Tax Code Section 34.05 for execution by the City manager.

BE IT RESOLVED that the City Council of the City of Lago Vista authorizes the City Manager to execute the tax resale deeds for the properties identified in Exhibit A.
