

**CITY OF LAGO VISTA
ORDINANCE NO. 22-11-17-01**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, PROVIDING FOR AN ORDER CANVASSING THE RETURNS OF THE CITY OF LAGO VISTA'S NOVEMBER 8, 2022 GENERAL ELECTION FOR THE OFFICE OF COUNCIL MEMBER PLACE 2, COUNCIL MEMBER PLACE 4 AND COUNCIL MEMBER PLACE 6, ALL OFFICES OF WHICH ARE ELECTED ON AN AT LARGE BASIS; PROVIDING FOR AN ORDER CANVASSING THE RETURNS OF THE SPECIAL ELECTION FOR THE PURPOSE OF SUBMITTING TO THE DULY QUALIFIED VOTERS OF THE CITY FOR THE CONSIDERATION OF PROPOSITION A, SHALL THE CAPITAL METROPOLITAN TRANSPORTATION AUTHORITY BE CONTINUED IN THE CITY OF LAGO VISTA, AND PROPOSITION B, THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF LAGO VISTA AT THE RATE OF TWO PERCENT (2%).

WHEREAS, on November 8, 2022, a General Election was held at which the qualified voters of the City had the opportunity to vote for the purpose of electing the hereinafter named officials; and

WHEREAS, the qualified voters of the City were also provided the opportunity to vote for the consideration of Proposition A, shall the Capital Metropolitan Transportation Authority be continued in the City of Lago Vista, and Proposition B, the adoption of a local sales and use tax in the City of Lago Vista at the rate of two percent (2%); and

WHEREAS, pursuant to and in compliance with the Texas Election Code, the City Council of the City of Lago Vista is required to canvass the returns of the General and Special Elections held on November 8, 2022, and the City Council having met to canvass the returns and to declare the results of said elections in the manner provided by law.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS:

SECTION 1. THAT, for the purpose of electing the hereinafter named officials, and it appears from said returns, duly and legally made, that there were cast at said election 4,573 valid legal votes; that each of the candidates in said election received the following votes:

SECTION 2. THAT, said election was duly called, that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Kevin Sullivan was duly elected to the Office of Council Member Place 2, Chelaine Marion was duly elected to the office of Council Member Place 4; that Paul Prince was duly elected to the office of Council Member Place 6; at large for the City of Lago Vista, Texas. Said above-named parties are hereby declared duly elected to their said respective offices, subject to the filing of their "Statement of Elected Official" and the taking of their "Oath of Office" as provided by the laws of the State of Texas. The Office term will commence at the regular Council meeting that the member of the Council has been declared elected and duly qualified for office.

SECTION 3. THAT, for the purpose of determining the results of the proposed measures, that there were cast for each of the Propositions the following votes:

PROPOSITION A

Shall the Capital Metropolitan Transportation Authority be continued in the City of Lago Vista?

Votes Cast Yes: 2,438

Votes Cast No: 2,013

PROPOSITION B

The adoption of a local sales and use tax in the City of Lago Vista at the rate of two percent (2%). Conditional upon a majority "NO" vote on Proposition A.

Votes Cast Yes: 1,392

Votes Cast No: 2,900

SECTION 4. THAT, the City Council further finds that such returns are correct and adopts them as the returns of the General Election and Special Election, that a copy of the Official Cumulative Report is attached hereto as Exhibit "A" and incorporated herein, and an Official Precinct Report is on file with the office of the City Secretary.

SECTION 5. THAT, Proposition A, resulted in the majority of qualified voters voting at the election having voted to pass said Proposition A therefore, Proposition A passed; and Proposition B, resulted in less than a majority of qualified votes voting at the election having voted to pass said Proposition B therefore, Proposition B failed to pass.

SECTION 6. THAT, it is found that the meeting of the City Council at which this Ordinance was adopted was open to the public and it is further found and determined that in accordance with the Order of this Governing Body that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

SECTION 7. THAT, all ordinances and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters ordained herein.

SECTION 8. THAT, if any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and this Council hereby declares that this Ordinance would have been enacted without such invalid provision.

SECTION 9. THAT, the recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.


SECTION 10. THAT, this Ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

PASSED AND APPROVED this 17th day of November 2022.


