Introduction

January was a productive month for the Police Department, with significant focus on administrative tasks and operational improvements. A substantial portion of our administrative team's efforts was dedicated to compiling end-of-year reports and analyzing departmental statistics. Our end-of-year reports will be completed and available for review during the month of February. Additionally, we continued the implementation of our new automated citizen feedback system, which we anticipate launching in late February or early March.

This month also presented challenges due to winter weather conditions. Despite the brief duration of the severe weather, our officers worked diligently to monitor road conditions and respond to various weather-related calls for service. Their dedication and professionalism in managing these situations were commendable.

In line with our commitment to continuous professional development, we conducted a department-wide training session on the operation of issued firearms. Enhancing officer proficiency with department-issued firearms is a key objective for the year, and this training marked the first in a series of planned sessions to achieve that goal.

Lastly, I participated in multiple meetings with the Texas Police Chief's Association Legislative Committee and was honored to receive notification of my reappointment by the President of the International Association of Chiefs of Police to continue serving on the association's Community Policing Committee.






Calls for Service – Historical and Year-to-Date


Summary


Summary
