## Juvenile Community Service Options

*Pursuant to Texas Code of Criminal Procedure § 45A.254, community service may be performed at the following types of organizations only:*

- *A governmental entity, non-profit organization, or another organization that provides services to the general public that enhance social welfare and the general well-being of the community as determined by the justice or judge.*
- *An educational institution*
- *By attending a tutoring program, work and job skills training program, a preparatory class for the high school equivalency examination administered under Section 7.11, Education Code, or similar activity.*

**If you wish to perform community service at an agency or organization other than those listed on page 2, YOU MUST CONTACT THE COURT FOR APPROVAL. If you fail to obtain court approval, your hours may be denied. If you have any questions about whether an organization is acceptable, you must contact the court for approval.**

**The list provided is not comprehensive and is simply intended to assist you in locating a community service agency. Please read through the list carefully, as each agency may have different requirements, and be aware that all community service hours will be verified by the Court.**

### TO RECEIVE CREDIT FOR COMMUNITY SERVICE

**You must turn in a letter on company/organization letterhead with your name and hours worked indicated with the printed name, signature and contact phone number of the person supervising the community service.**

Those defendants performing community service will be expected to comply with all rules and regulations of the agency where the hours are being performed. Disrespectful behavior or vulgar language will not be tolerated, and appropriate attire must be worn. **Failure to comply with the agency's policies could result in a denial of community service.**

**IMPORTANT NOTICE:** Juvenile non-traffic records are confidential. Information regarding Juvenile cases cannot be given over the phone or via email unless it is from a number/address already provided to the Court. Otherwise, the Juvenile and/or parent must appear at the Cedar Park Municipal Court with photo identification to obtain further information about their case, OR submit a signed (manually or electronically by typing your full name) request and photo identification.

## **Juvenile Community Service Provider / Job Descriptions**

### **Lifelong Friends Pet Adoption**

Clean litter boxes, kennels and other duties assigned. Must sign up for 2 or more hours per day.

### **Travis County Rural Community Centers:**

Organizing the clothing closet/food pantry, and making food packages for families, and picking up trash inside and outside of the agency. \*Must be mature and able to work independently with little supervision.

### **Goodwill Industries of Central Texas**

Ages 16 and older have the option of working in the Goodwill retail stores or on a service project.

### **Open My World Therapeutic Riding Center**

Work will involve grounds keeping, painting, fence repairs and raking leaves. Ages 13 and under may work with the petting zoo animals. Ages 15 and older may be asked to help with direct care of horses.

### **Neighborhood Sports**

Work will involve picking up trash, working with soccer leagues and a variety of misc. work.

### **Life Steps**

Work will consist of janitorial duties.

### **Habitat for Humanity Restore:**

Work will include customer service (selling, answering questions, helping customer load products onto carts), pricing, stocking and organizing merchandise, cleaning, and answering the phones.

The **ReStore** is the only approved location for earning **community service restitution hour's credit** at Austin Habitat for Humanity. If you are working towards accruing **mandated court hours** remember to bring your photo id and any related paperwork.

#### **Volunteer Registration:**

All volunteers are **required** to go create a Volunteer User Account. If you appear at ReStore to volunteer and you have not signed up ahead of time for the volunteer event, you will **not** be allowed to volunteer. No exceptions.

#### **Youth Policy**

Volunteers (16 and 17 years old) may volunteer at the ReStore, **if accompanied by a parent or guardian over the age of 21.**

Please dress appropriately for volunteering; be prepared for seasonal temperatures, wear work clothes, closed-toed shoes, and no dangling jewelry.
