4. Map data is from the Lago Vista Police Department – Dispatch Division.




Introduction

May was a productive month for all divisions within the Police Department. A key highlight was the Community Listening Session event, attended by several community members. These events provide an opportunity for the community to learn about the Police Department's activities, ask questions, and voice concerns in a collaborative environment. We are planning to hold another session later this year.

Additionally, this month was significant for professional development. Several members of our Dispatch team participated in high-quality training opportunities, and our department's Captain completed the first module of the Leadership Command College, a nationally recognized law enforcement leadership development program. Furthermore, multiple team members completed CPR, first aid, and Narcan training provided by ESD 1.

We also made a small operational change: starting May 30th, our lobby hours have been extended to 7:00 AM to 6:00 PM, Monday through Sunday. Previously, our lobby was open only Monday through Thursday during the City's business hours. This change was implemented in response to community feedback aimed at improving accessibility and service.

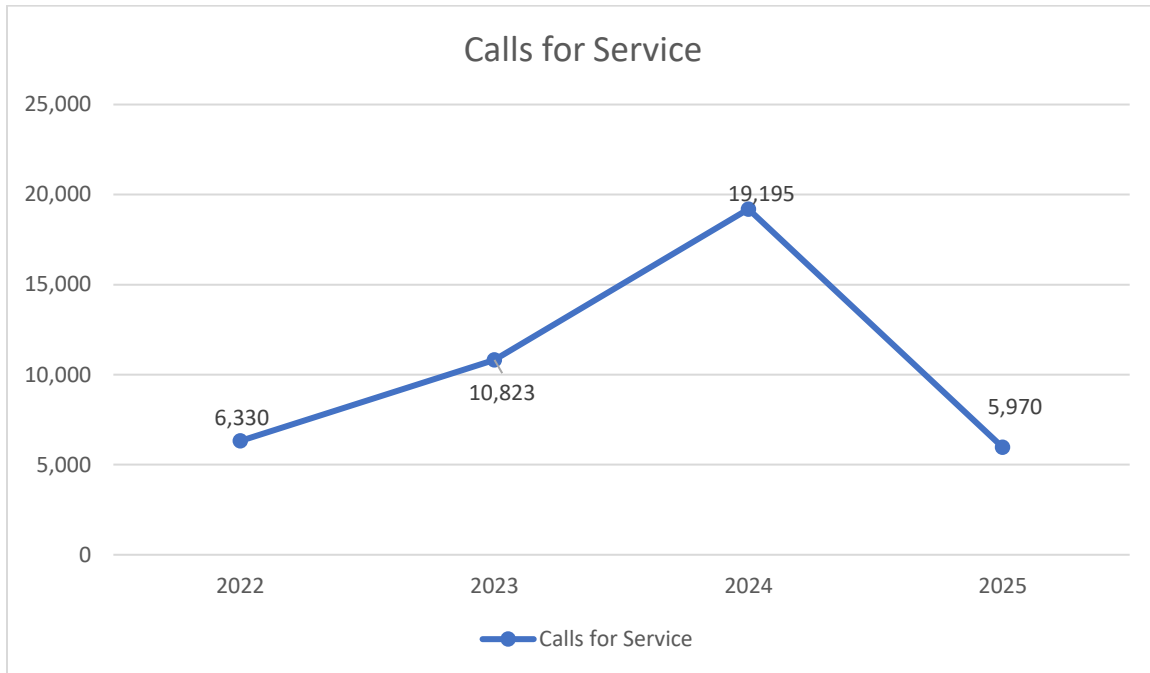

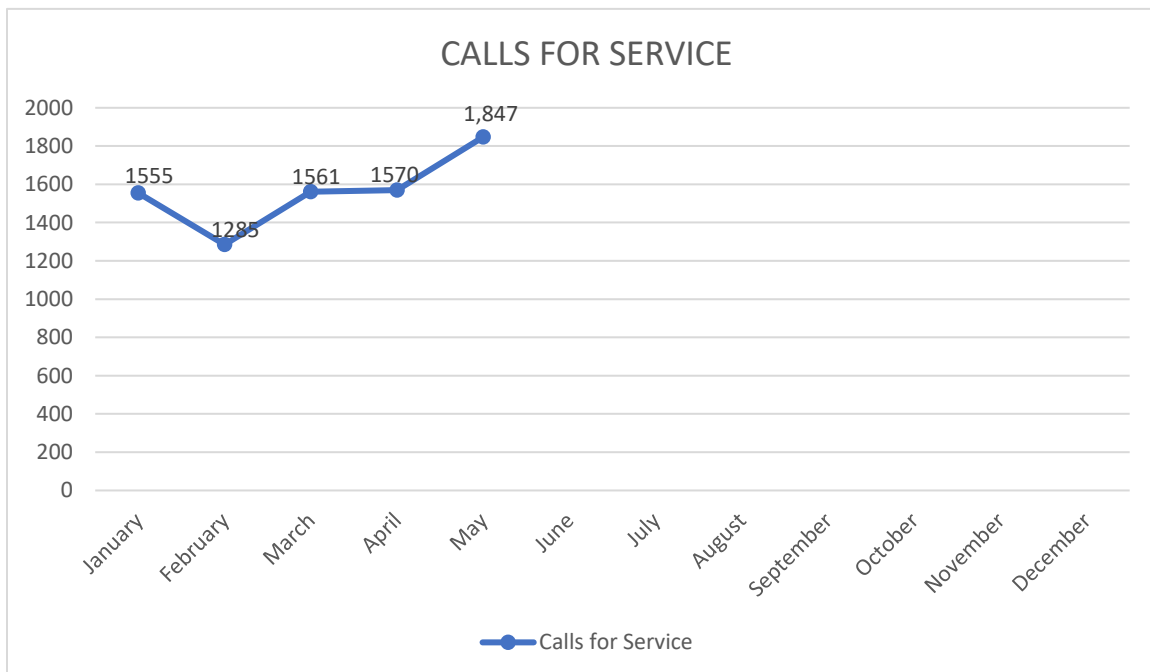

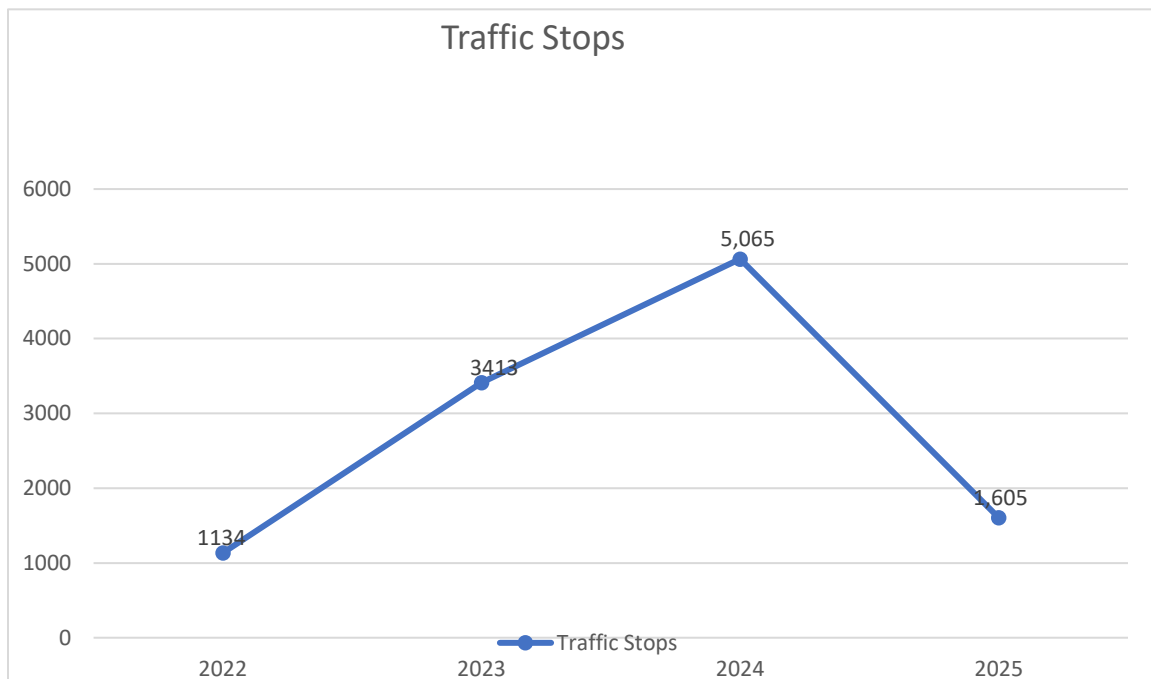
Calls for Service – Historical and Year-to-Date

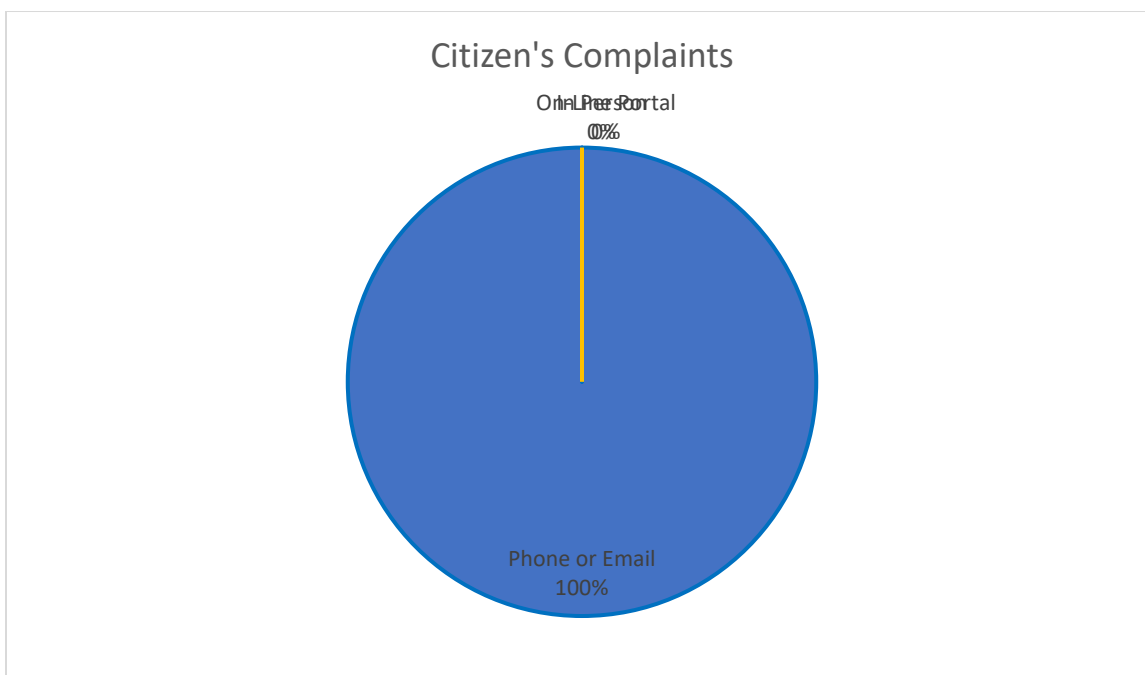
Summary

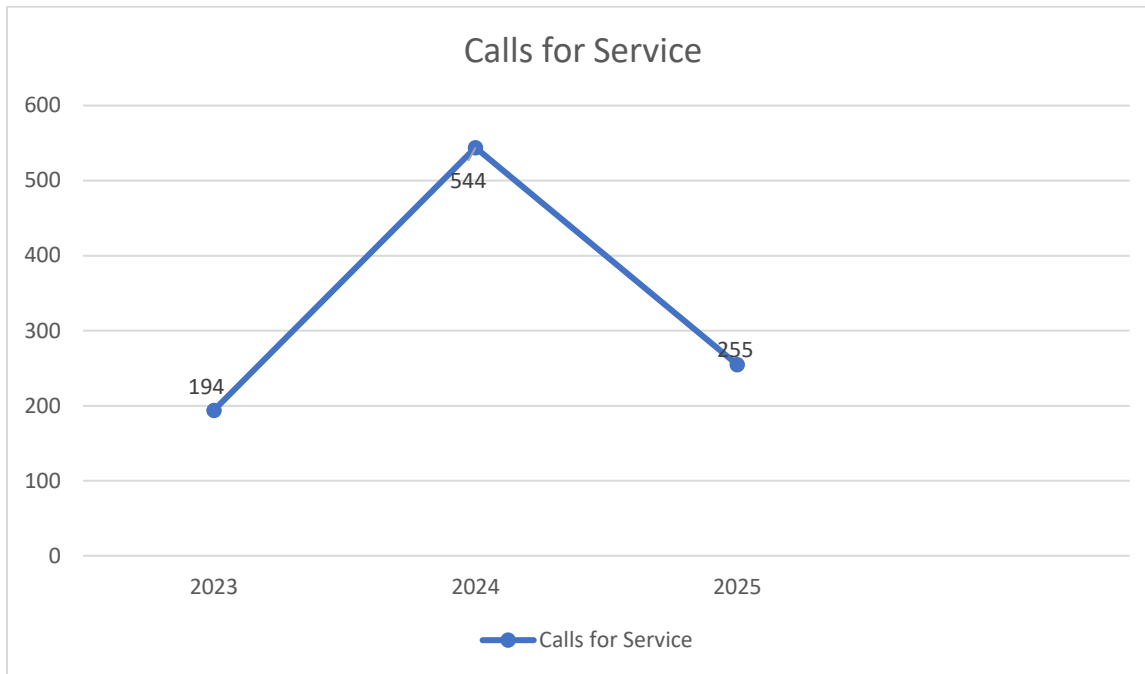

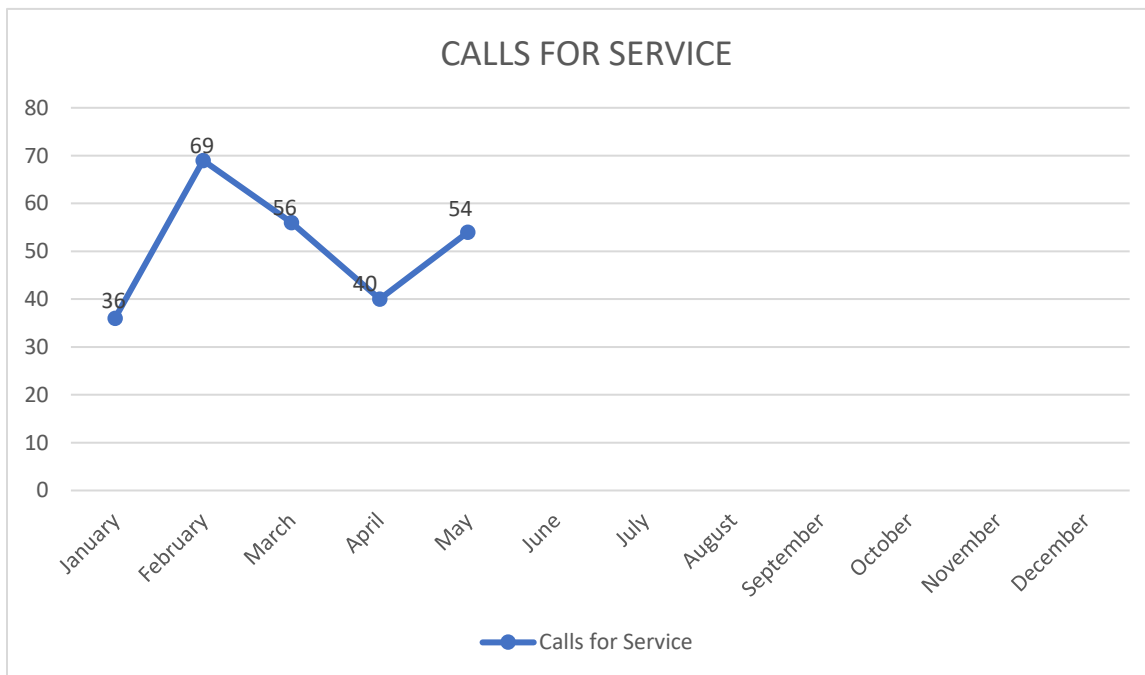
Animal Control Statistics – Citizen Complaints

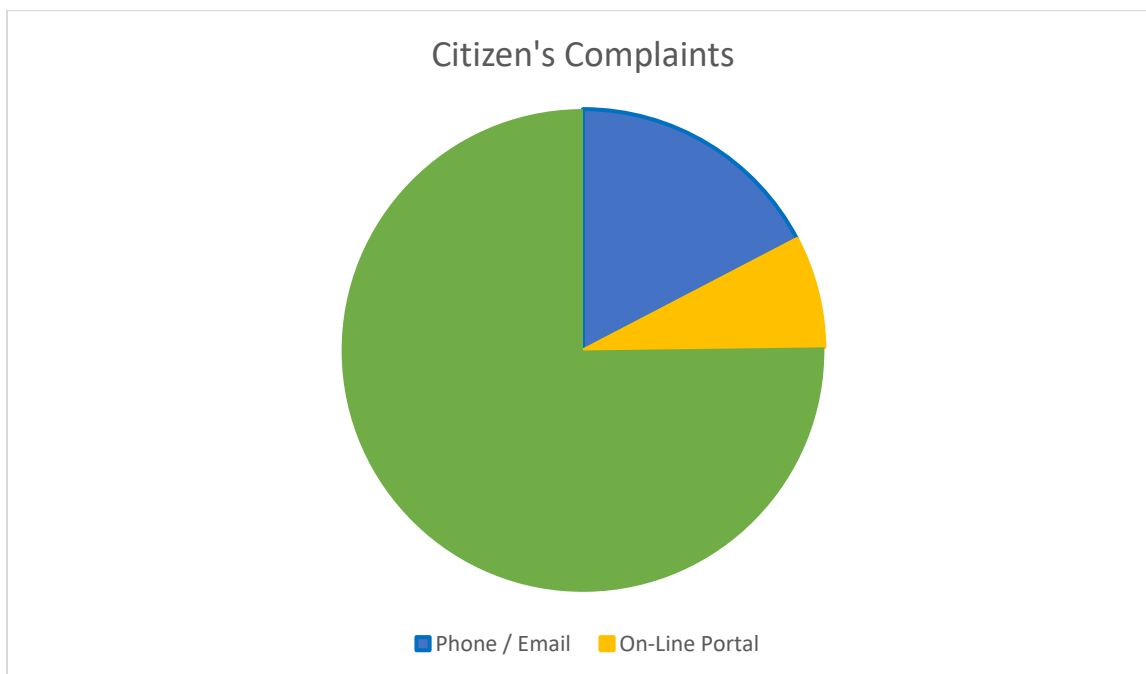
Summary

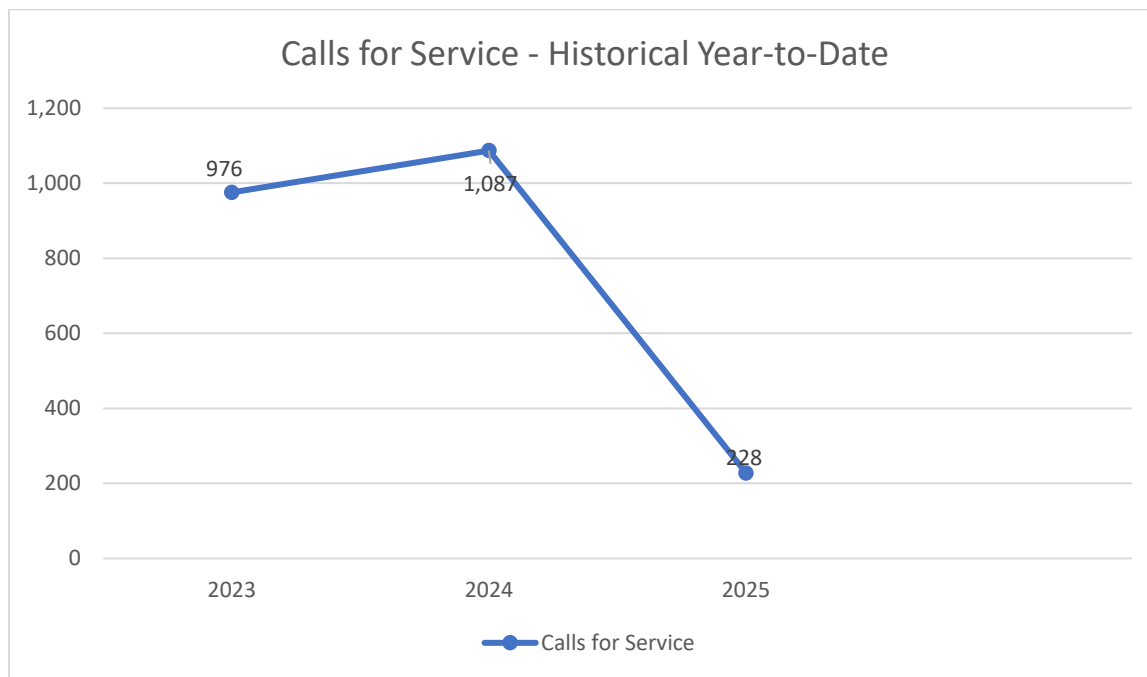

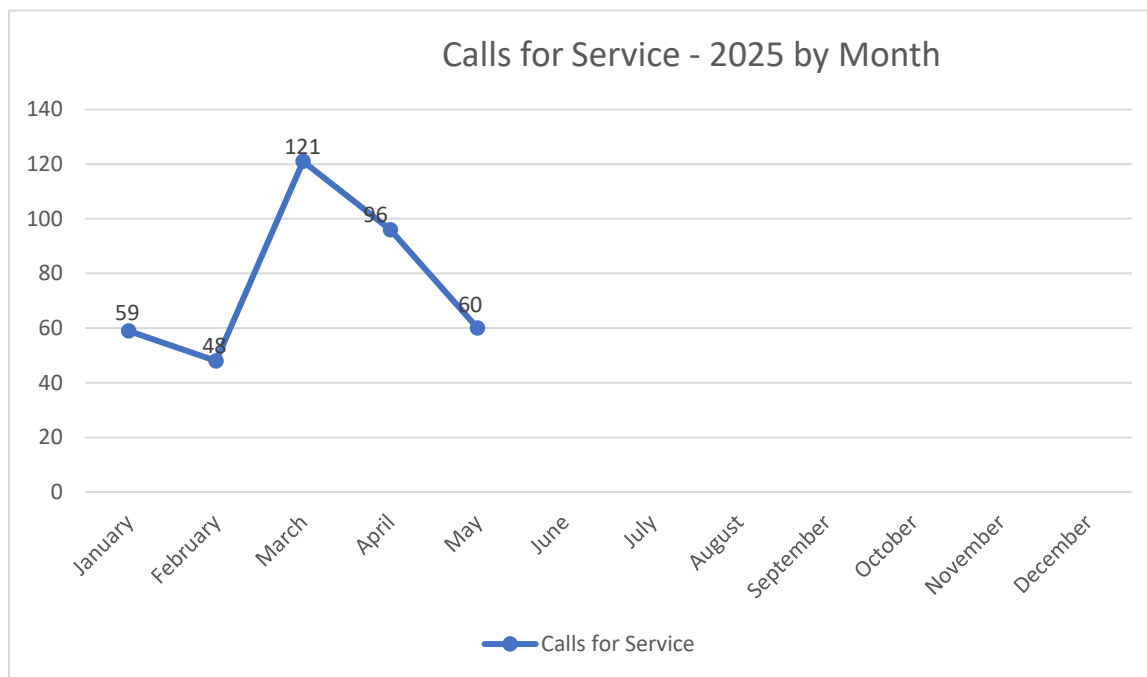
Code Compliance Statistics – Citizen Complaints



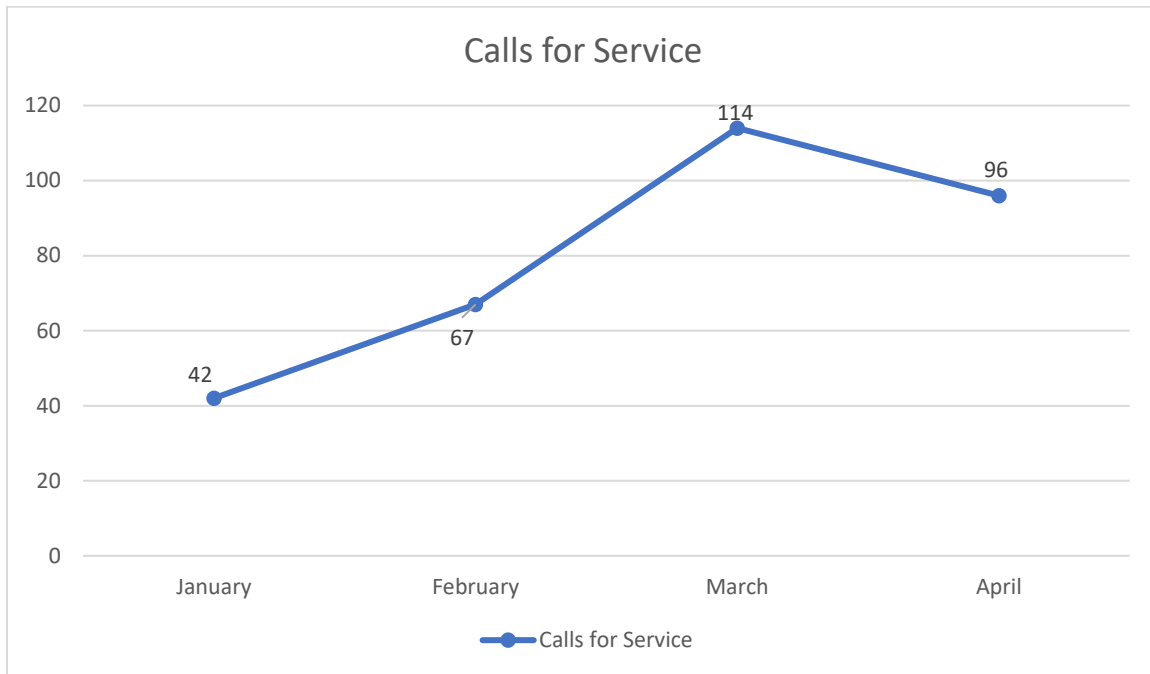
Calls for Service – Historical and Year-to-Date



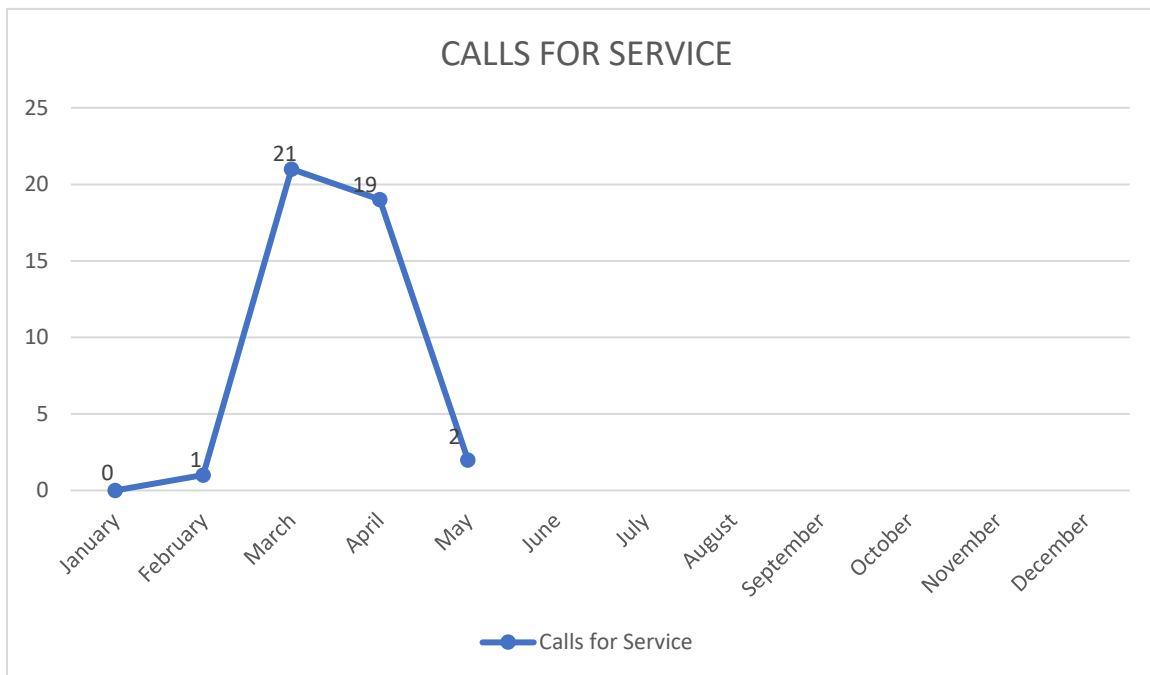
Calls for Service – 2025 by Month

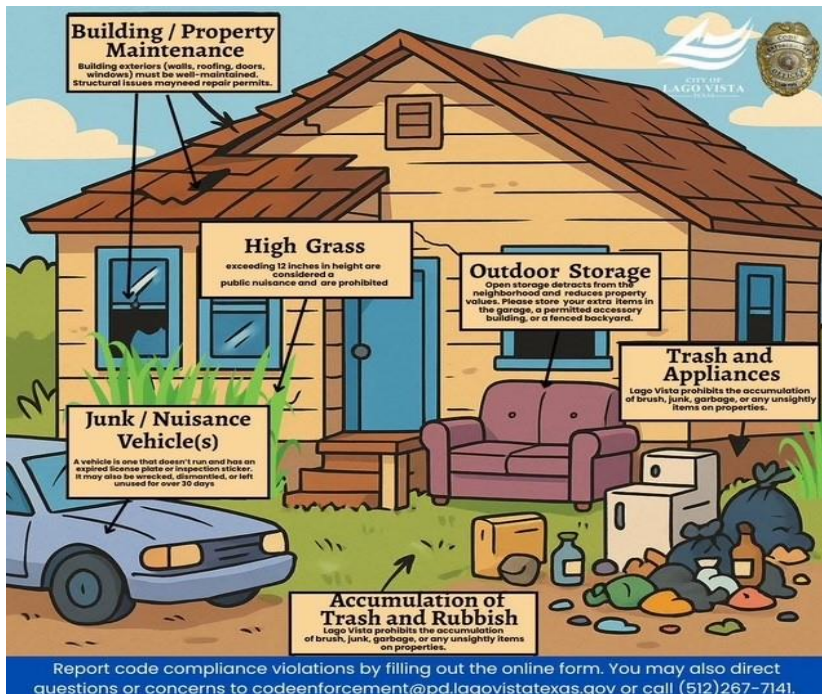

DID YOU KNOW?

With Code Compliance

- 1 The electric services shall be installed in accordance with the National Electrical Code (NEC) and the National Electrical Safety Code (NESC) with the following exceptions:
- 2 Marina facilities providing electrical service to low power consumers (15 amps or less) shall not be required to design electrical service based on the cumulative capacity of a 15 amp GFI circuit breaker; and.
- 3 No open wiring shall be permitted.
- 4 All overhead primary electric lines installed after effective date of this article.
- 5 Underground primary electric lines shall be installed in accordance with the NESC and all surface mounted facilities shall be restricted to elevations not subject to frequent flooding.
- 6 A properly executed easement over the properties traversed shall be obtained from a primary line.
- 6 The attachment of the service cable* to the floating structure shall be a design flexibility under changing lake levels. The ground conductors shall be electrically bonded to all metal parts.

Structural Requirements

Sec 1.607

Structural Integrity

All structures must meet the Uniform Building Code (excluding Part I) and ASCE Report #50 standards, withstanding wind and wave impact when fully loaded. Alternate standards require prior approval.

Anchoring

Structures must be securely anchored or moored to remain stable during Lake Travis's typical wind and wave conditions.

Flotation Materials

Floating structures must not use metal drums. Approved materials must be securely attached, weather-resistant, and fuel-resistant on docks handling petroleum.

Lake Level Flexibility

Floating marinas must be designed to adjust for changing lake levels.
