1. What is the agency's mission?

The mission of Lago Vista Firewise is to enable neighbors to help their neighbors take action to reduce their wildfire risk by implementing the Firewise USA® program of the National Fire Protection Association in Lago Vista, TX. A 100% volunteer community service organization.

2. What are the goals of the program for which you are requesting funding?

1. Rebuild Lago Vista Firewise by recruiting a strong base of volunteers.
2. Conduct multiple volunteer training events through the year to equip volunteers.
3. Conduct ongoing educational social media campaigns.
4. Conduct monthly virtual meetings for Firewise Q&A, open to all community members.
5. Begin offering free home assessments to residents of Lago Vista so they may be informed of specific actions they can take to make their homes safer in the face of wildfire.

3. How will you know you met these goals by the end of the funding year?

All of our goals can be quantitatively measured: # of new volunteers, # of volunteers trained, # of educational social media posts, # of Firewise Q&A virtual meetings, and # of Firewise Home Assessments provided.

4. Describe the impact of services on the community

Successful implementation of Firewise USA in Lago Vista, makes homes less susceptible to wildfire and residents better prepared to survive should a wildfire event occur in our near Lago Vista.

5. If the request for funding for the proposed fiscal year is an increase from the previous fiscal year, please justify such increase:

We are requesting the same as in the last year we received funding from the City of Lago Vista. Our costs are low and are mostly associated with the costs of providing events, printing or purchasing educational materials, maintaining or website, and software tools/storage used by our volunteer members to operate the organization.

As this is a year of rebuilding the organization, we do not have an approved budget at this time. Our organization is a very low-budget organization currently covering costs through individual donations from our members and community members. A formal budget will be approved this summer by our recently formed leadership committee. Our budget for CY 2026 will be approved in November 2025.

Our CY 2025 expenses to date are:

\$600 - 3/4-day volunteer training event.

\$200 - website hosting and domain registration fees.

Additional CY 2025 expected expenses:

We plan to conduct two more new volunteer training events and will need to produce educational handouts for outreach events and assessment forms and guidance for our home assessment program.
