

RESOLUTION NO. 25-2159

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, AUTHORIZING THE RELEASE OF TWO, FIFTEEN-FOOT PUBLIC UTILITY AND DRAINAGE EASEMENTS ADJACENT TO THE COMMON BOUNDARY LINE OF LOT 32009, HIGHLAND LAKES ESTATES, SECTION THIRTY-TWO, A SUBDIVISION OF RECORD IN VOLUME 68, PAGE 10, PLAT RECORDS OF TRAVIS COUNTY, TEXAS AND LOT 32001-A, HIGHLAND LAKES ESTATES, SECTION THIRTY-TWO, A SUBDIVISION OF RECORD AS SHOWN ON THE REPLAT RECORDED IN DOCUMENT NO. 202200168, OFFICIAL PUBLIC RECORDS OF TRAVIS COUNTY, TEXAS LOCATED AT 21301 BOGGY FORD ROAD AND 3133 NOBLE CIRCLE, LAGO VISTA, TEXAS; AND PROVIDING AN OPEN MEETINGS CLAUSE.

Whereas, the applicants and property owners, Philip Smith and Cindy Smith, request the release of two, fifteen-foot public utility and drainage easements adjacent to the common boundary line of Lot 32009, Highland Lakes Estates, Section Thirty-two, a subdivision of record in Volume 68, Page 10, Plat Records of Travis County, Texas and Lot 32001-A, Highland Lakes Estates, Section Thirty-two, a subdivision of record as shown on the Replat recorded in Document No. 202200168, Official Public Records of Travis County, Texas. The subdivision plat is attached as Exhibit A;

Whereas, the owners plan to consolidate the two lots into one larger lot to allow for the construction of a single-family residence garage addition and driveway to Noble Circle - an exhibit showing the location of the easements to be abandoned is attached as Exhibit B;

Whereas, Staff has verified all easement interest holders have abandoned their easement interests and confirmed that the easements may be released;

Whereas, the easements are located on properties addressed as 21301 Boggy Ford Road and 3133 Noble Circle, Lago Vista, Texas, Travis CAD ID Nos. 170368 and 970781;

Whereas, Staff recommends Council authorize the release of two, fifteen-foot public utility and drainage easements adjacent to the common boundary line of Lot 32009, Highland Lakes Estates, Section Thirty-two, a subdivision of record in Volume 68, Page 10, Plat Records of Travis County, Texas and Lot 32001-A, Highland Lakes Estates, Section Thirty-two, a subdivision of record as shown on the Replat recorded in Document No. 202200168, Official Public Records of Travis County, Texas and located at 21301 Boggy Ford Road and 3133 Noble Circle, Lago Vista, Texas; and

Whereas, the City Council has considered the matter and deems it in the public interest to authorize this action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, THAT:

Section 1: Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Lago Vista, Texas, and they are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.


